IOGP 476 Report - updated April 2023

A brief extract from the updated report follows below.

Employers are responsible for assuring that all personnel who can influence choice or operation of well barriers have role- and operation-specific well control training.

Training should be focused on specific roles and the training should enable individuals to gain the skills to demonstrate capability to fulfil their own well control responsibilities.

Personnel involved in well operations should participate in continuous learning. Continuous learning can be achieved in a multitude of ways which may include online training, worksite training, face-to-face refresher training, and documented simulation exercises and facilitated scenario-based discussions with the crews at a worksite.

Additional training, where applicable to manage the risks, should be tailored specifically for the nature of the operations being performed, the environment the activity is in, the type and location of the rig or of the intervention unit.

Well Control Training - Levels Guidance Chart

IOGP 476 Chart Updated

The Guidance Chart indicates training required for roles, responsibilities and levels, including desired outcomes and frequency of renewal.

The main objective is to ensure that the Operator and Employer review the crew training required to manage and mitigate risks.

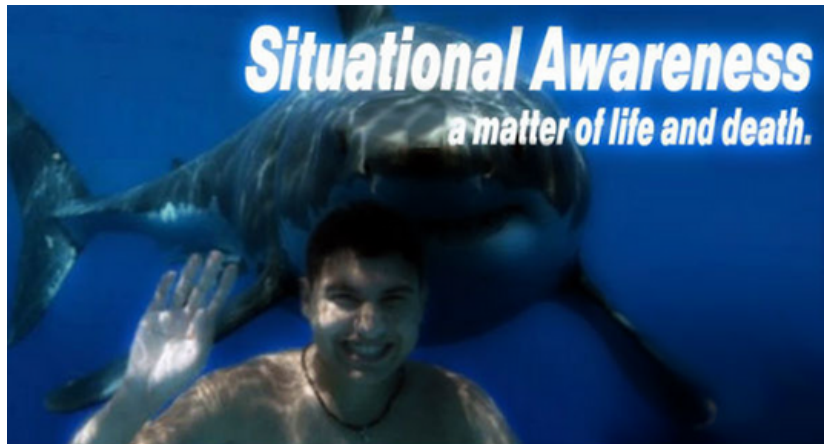

Situational Awareness (SA)

Situational awareness is being aware of what is going on around you and what is likely to happen in the near future.

To ensure Crew maintain Situational Awareness Supervisors should:

- Plan ahead by briefing personnel on the nature and risks of a given task prior to performing the task i.e. pre-job meeting
- Observe crews physical and mental fitness for work, signs of lowered SA
- Interact with crew to enhance alertness and ensure task focus
- Reassign duties that are less hazardous to inattentive crew



Crew can maintain Situational Awareness by:

- Being assertive when unsure of procedures
- Avoiding the need to work under imposed time pressure
- Time out for safety (TOFS) / 5x5 / STOP - use this to regroup
- Follow rules, procedures and Standard Operating Procedures,
- Communicate - Ask for help

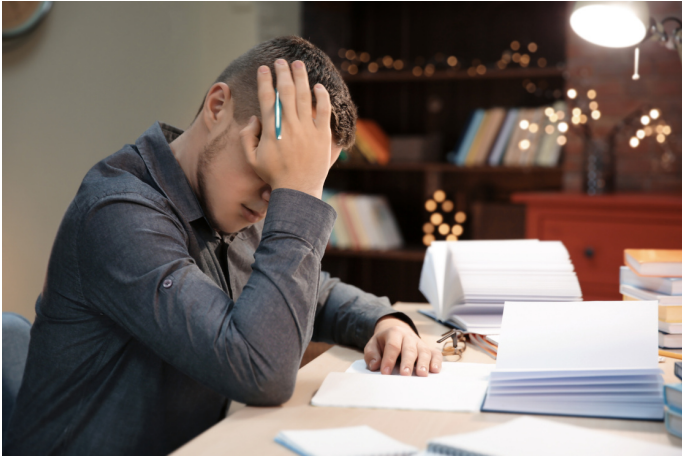

Managing Assessment Anxiety

Assessment anxiety can be a debilitating condition, we have candidates arrive on assessment morning, having had a sleepless night.

We have had candidates say that they are so stressed before and during assessments that they find their mind goes blank and they can't recall any relevant information.

With this in mind we felt it was important for us to provide some tips to help candidates deal with assessment anxiety.

Below follow a few suggestions to ease the anxiety:

- *Communicate with either your instructor or centre manager, your fears will be treated with the strictest confidence.*
- *Don't stay up late studying the night before your assessment. Feeling tired will negatively impact your concentration and memory.*
- *Exercise prior to an assessment, releases chemicals in the brain to sharpen one's ability to learn and think.*
- *Avoid stimulants such as caffeine prior to your assessment as this may worsen feelings of anxiousness.*
- *Learn a relaxation technique that you can do whilst in the assessment room, such as slow breathing.*
- *If you do not pass your assessment first time round, you have two re-sits available to you, let's see what we can do to work through your problem areas together.*

While there are many contributors to assessment anxiety, being prepared and organised assists candidates to keep focus on and be in control.
